
A BYLAW OF THE RURAL MUNICIPALITY OF PROGRESS NO. 351 TO PROVIDE FOR ENTERING INTO AN AGREEMENT RESPECTING THE MAINTENANCE OF A PAVED ROAD

The Council of the Rural Municipality of Progress No. 351, in the Province of Saskatchewan, enacts as follows:


- 1, The Rural Municipality of Progress No. 351 is hereby authorized to enter into the agreement attached hereto and forming part of this bylaw and identified as Exhibit "A". with the Town of Luseland, for the purpose stated within the agreement.
2. The Reeve and the Administrator of the Rural Municipality of Progress No. 351 are hereby authorized to sign and execute the attached agreement identified as Exhibit "A".

MEMORANDUM OF AGREEMENT

This agreement made in duplicate this 4th day of September, 2019 between:

THE TOWN OF LUSELAND, in the Province of Saskatchewan

- and -

THE RURAL MUNICIPALITY OF PROGRESS No. 351, with office in the Town of Luseland,
in the Province of Saskatchewan

WHEREAS the Town of Luseland owns and maintains Range Road 3244 from the junction
with Township Road 362 southward to the Provincial Highway 31,

AND WHEREAS the Town of Luseland and the Rural Municipality of Progress No. 351 have
jointly paved the aforementioned road,

NOW THEREFORE, the Town of Luseland and the Rural Municipality of Progress No. 351
agree to share equally in the normal cost of maintaining the said road, which would include
costs of crack-filling and patching.

The Rural Municipality of Progress No. 351 agrees to the above provision only so long as the
Town of Luseland controls the weight and speed restrictions at the present limits.

This agreement is no longer valid if the restriction were to be removed.

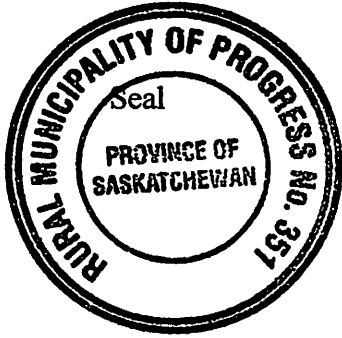
